

This document lists the traditional knowledge literature reviewed by the Hemmera team in order to prepare specific content excerpts for Casino's technical team as they prepare supplementary information for the project proposal. The listing reflects suggestions provided through comments on the YESAB On-line Registry, Hemmera's suggested documents and other sources uncovered through the exercise of retrieving these sources. The focus was first on Northern Tutchone specific information, then on Yukon information and lastly approaches for North of 60. The documents listed below were each reviewed for relevant information as it relates to the topics of vegetation, wildlife, birds and fish, as well as more holistically as they related to traditional ecological knowledge or traditional land use.
