1. OVERVIEW

Casino is a proposed modern, responsible copper, gold, molybdenum, and silver mine located in the Yukon. In October 2024, Casino completed and submitted its Environmental & Socio-economic Effects (ESE) Statement, entering the Panel Review stage, the highest level of environmental and socio-economic assessment in the Yukon.

Our communications priorities reflect transparency, responsiveness, and relationship-building, particularly with the five affected First Nations and Yukon communities.

- » Estimated annual budget range

6. Relevant Experience & Case Studies

- » Three (3) examples of similar work
- » References from clients (preferably northern, Indigenous, or mining sector)

7. Value-Added Services (optional)

- » Creative design
- » Reputation monitoring tools
